| Subject | : Fulfillment of coal demand for national electricity |

- 1. President Director of PKP2B company holder
- 2. President Director IUP operation production holder, IUPK Operation Production, IUPK as contract extension.
- 3. President Director of Transportation and Trade permit holder company.

In connection with the letter from the PT PLN (Indonesia Power Company) Number 77875/EPI.01.01/C0100000/2021-R in 31st December 2021 pertaining to coal stock crisis for national power plan and IPP that explain the shortage amount of coal in critical and the coal supply is very low, thus we convey hereby:

- 1. Coal stock in PLTU PLN Group and *Independent Power Producer* (IPP) now is critical and on the low demand, so as the result it will interfere the PLTU operational that will affect to the national electricity.
- In accordance to the Provision number 157 chapter (1), Provision number 158 chapter (3), government regulation number 96 year 2021, Regulation of Ministry of Energy and Mineral Resource number 7 year 2020, that revised to regulation of Ministry of Energy and Mineral Resource number 16 year 2021 stated that.
 - a. Provision 167-chapter (1) PP number 96 year 2021
 IUP or IUPK holder in the operation and production shall prioritize the local mineral and/or coal for the national interest.
 - b. Provision 158-chapter (3) PP Number 96 year 2021
 IUP and IUPK holder in the operation and production able to export the coal commodity that produced after the local needs is fulfilled.
 - c. Chapter 62 text g Permen ESDM number 7 year 2020
 IUP and IUPK holder shall prioritize the mineral and coal national needs and follows control and sells production.
- According to the requirement on the ESDM ministry Number 139.K/HK.02/MEM.B/2021 about the fulfillment of coal need for national market. Hereby stated that in the urgent condition that the coal stock is not fulfilled. Dirctor General of mineral and coal under the Ministry of ESDM could appoint IUP, IUPK, PKP2B, IUPK holder as the continuous of contract operation to fulfill the local coal demand.

Based on the above circumstances, and in order to secure coal supply for the national electricity, also to anticipate the extreme weather in January 2022 into Febuary 2022, then to all company that holds appoint IUP, IUPK, PKP2B, IUPK, IUPK can be used as operation production contract/agreement and holder of coal trade and transport.

- 1. Prohibition to export coal since 1 to 31st January 2022.
- 2. Should supply all coal production to fulfil the national or people demand and/or delegation from government with PLN and IPP.
- 3. If there is coal in the loading port and/or can be carriage into ship to be shipped to PLTU that owned by PT PLN group and IPP, that the applications hall been completed by PT PLN Persero.

The prohibition of coal export above will be evaluate and recheck again based on the realization of coal stock for PLTU group PT PLN and IPP.
