**The Standard Club UK Ltd – new banking arrangements – urgent action required**

## **Change of The Standard Club UK Ltd's VAT Number**

The Standard Club UK Ltd's VAT number, 244 365 464, has been withdrawn and replaced with a new VAT number of 365 342 691. Please update your records so that any future documentation addressed to The Standard Club UK Ltd which needs a VAT number displays the correct number.

## **New banking arrangements**

Following a decision by Nordea Bank to close their London Branch, the club's London accounts will cease to operate on 30 June 2021, so the bank accounts held with Nordea Bank Abp, London branch will be switching to Nordea Bank Abp, Oslo Branch with immediate effect.

**We kindly request therefore that, going forward, all remittances are made to the new Nordea Oslo branch accounts. Please instruct your accounts teams to take urgent action to update their records as per the following:**

**Account name (for all accounts listed below):** The Standard Club UK Ltd  
**Bank:** Nordea Bank Abp, Oslo Branch  
**Swift BIC Code:** NDEANOKK

These bank accounts should be used for all the club's business classes: P&I, Defence, Coastal & Inland, War Risks and Strike & Delay, so if you buy more than one class of cover, this should mean less remittances for your accounts team to process.
