### WAR RISKS CLASSES - ADDITIONAL PREMIUM AREAS

In accordance with the provisions of Rule 19.4 of the North and Standard Club War Risks Rules, we hereby give you notice that the Directors of each of NorthStandard Limited, North of England P&I DAC, The Standard Club UK Limited and The Standard Club Ireland DAC, have determined in exercise of their powers under Rules 19.3 and 19.3.1, that the Additional Premium Areas shall be amended.

The following area is added:

**3) Inland waters of Russia within the following areas:**

- a. Crimean Peninsula
- b. River Don, from Sea of Azov to vertical line at 41° E

**2) All inland waters of Ukraine, including inland waters within Crimea and other Ukrainian territories under Russian control**

This notice is effective immediately and with effect from 00.01 hours GMT 11 May 2023, the Additional Premium areas will be as follows :

## **1 Africa**

- a. Nigeria
- b. Somalia
- c. Libya
- d. Benin
- e. Gulf of Guinea, but only in respect of the waters enclosed by the following boundaries:
  1. On the west, from the coast of Togo  $6^{\circ} 06' 45''$  N,  $1^{\circ}12$ E, south to
  2. high seas point  $0^{\circ} 40'S$ ,  $3^{\circ} 00'E$
  3. and then east to Cape Lopez Peninsula, Gabon  $0^{\circ}40'S$ ,  $8^{\circ} 42'E$ .
- f. Togo
- g. Cabo Delgado in respect of the waters within 50 Nautical miles of Mozambique and Tanzania enclosed by the following boundaries:
  1. To the north, from Mnazi Bay at  $10^{\circ}19.6'S$ ,  $40^{\circ}18.9'E$  to high seas point at  $9^{\circ}50.7'S$ ,  $41^{\circ}7.6'E$ .
  2. To the south, from Baía do Lúrio at  $13^{\circ}30'S$ ,  $40^{\circ}31.6'E$  to high seas point  $13^{\circ}30'S$ ,  $41^{\circ}28.8'E$ .

Iran-Pakistan border at 25°10.5'N, 61°37.5'E excepting coastal waters of adjoining territories up to 12 nautical miles offshore unless otherwise provided

- i. Syria
- j. United Arab Emirates
- k. Yemen

### **4. Indian Ocean/Arabian Sea/Gulf of Aden/Gulf of Oman/Southern Red Sea**

The waters enclosed by the following boundaries:

- a. On the north-west, by the Red Sea, south of Latitude 15° N
- b. on the northeast, from the Yemen border at 16°38.5'N, 53°6.5'E to high seas point 14°55'N, 53°50'E
- c. on the east, by a line from high seas point 14°55'N, 53°50'E to high seas point 10°48'N, 60°15'E, thence to high seas point 6°45'S, 48°45'E
- d. and on the southwest, by the Somalia border at 1°40'S, 41°34'E, to high seas point 6°45'S, 48°45'E

### **5. Russia**

### **6. Europe**

Sea of Azov and Black Sea waters plus inland waters as defined below:

- 1) Sea of Azov and Black Sea waters enclosed by the following boundaries:
  - a. On the west, around Romanian waters, from the Ukraine-Romania border at 45° 10.858'N, 29° 45.929'E to high seas point 45° 11.235'N, 29° 51.140'E
  - b. thence to high seas point 45° 11.474'N, 29° 59.563'E and on to high seas point 45° 5.354'N, 30° 2.408'E



- c. thence to high seas point 44° 46.625'N, 30° 58.722'E and on to high seas point 44° 44.244'N, 31° 10.497'E
  - d. thence to high seas point 44° 2.877'N, 31° 24.602'E and on to high seas point 43° 27.091'N, 31° 19.954'E
  - e. and then east to the Russia-Georgia border at 43° 23.126'N, 40° 0.599'E
- 2) All inland waters of Ukraine, including inland waters within Crimea and other Ukrainian territories under Russian control

**3) Inland waters of Russia within the following areas :**

- a. River Don, from Sea of Azov to vertical line at 41° E
- b. River Donets, from River Don to Ukraine border

**4) All inland waters of Belarus south of horizontal line at 52° 30' N**

The ports, places, countries, zones and areas listed shall include all harbours, offshore and installations and terminals unless otherwise stated.

Notice must be given to NorthStandard before an Entered Ship proceeds into an Additional Premium Area. NorthStandard will endeavour to provide indications of Additional Premium levels at any time, but firm quotations will not normally be available until the Entered Ship is within 48hrs of arrival into the additional premium area.
